The most recent occurred in April of 1978 when plaintiff was assaulted and seriously injured, as a result of which he was hospitalized for more than a month. He was also the victim of an assault in October of 1978. There is evidence that inmate pressures can affect the administration of the penitentiary, but there is no evidence that the defendants acted in any respect that the defendants were negligent.
