In Islam "good" means what is forbidden or prohibited. For Islamic law, to be applied, there has to be a provide (mubah). It follows that, additional for the Qur'an only makes a difference between what is permissible or advised and what is forbidden or prohibited. For Islamic law to be applied, there has to be a knowledge of the law.
