the editors response to the request is somewhat peculiar. the editors cite the need to protect the privacy of the israels victims and their families as the main reason why the requested documents must not be released, but this is an odd justification. if the documents are properly redacted, the privacy concerns can be easily mitigated. the editors then go on to argue that as this is a murder trial, the documents should be kept secret in order to protect the

integrity of the trial. this is odd. the legal requirements to establish the guilt of the suspect are not the same as those required to judge the case. it is odd that the editors cite the legal requirements for the crime to be tried, but then posit the law that applies to the case itself. the executive order and the law it references do not stand in opposition to each other. the executive order cited

by the prosecutors does not mean that the documents are not protected by the law, but that they can be redacted in order to protect the privacy of the israels victims and their families. the press cites several relevant laws. they say that the prosecutor may not release documents that are protected by the legal requirements of the case. however, they also cite rule 16 of the federal rules of criminal procedure, which states that the court may release the documents, if it decides that the risk of harm outweighs the public interest in disclosure. this is, in essence, the standard the press uses in order to argue that the documents should not be released. they argue that the israeli public and the palestinians are entitled to

know everything about this case. they conclude that this principle should, in most circumstances, override the need for the protection of the victims and their families. they claim that this is a case that the israeli and palestinian publics are entitled to know about. they also say that the israeli public is entitled to know that the murderer will be tried and will not go free, and that the palestinian public is entitled to know that the murderer will be punished. 5ec8ef588b
